- 6. Society Change of address in Income tax department record has been initiated, Currently Mr. Anil Kumar Arora address is being used. CA Ambrish Rastogi will update the progress to the Society members in next 7 to 10 days time.
- 7. Reliance Communication Ltd. has not paid the license fee since 1st Oct 2017 for the space allocated to them. Estate office has made many follow-ups with their officials and Management, no response till date. As per market sources, The Company have shut down or sold their Telecom business. Outstanding amount of Rs. 1,77,455/- is showing in billing system till date and account has been immobilized and security deposit laying with society suppose to be forfeited as per agreement. Request letter to forfeit the security deposit is under approval with Members consideration.
- 8. Submersible pump is stuck-up inside the bore-well (around 180 ft deep), few vendor has submitted their quote to pull out/lift the motor-pump from well without any guarantee and minimum payment will be charged incase not able to pull the submersible:
