## Following issues have been discussed during meeting held on 27th October 2018

- Purchased of 2 nos. new Elevators from M/s Kone have been finalized by the members in last meeting, revised quote for ISMC 150 channel and AMC quote after completion of 24 months warranty period discussed with M/s KONE.
  - a. Revised cost of elevators along with ISMC Channel has been negotiated for Rs. 27,00,000/- inclusive of GST per lift and in this quote Chemical Fastener also being added as complimentary (Total cost of 2 elevator will be Rs 54,000,00/- inclusive of GST), society have also negotiated warranty period and same has been extended by KONE from 12 months to 24 months from the date commissioning of elevators.
  - b. AMC for 1<sup>st</sup> year after completion of 24 month warranty period was quoted by KONE 5% of elevator cost which become Rs. 1,35,000/- per elevator, after negotiation meeting it was negotiated and finalized for Rs. 90,000/- PA and thereafter increase/hike in AMC cost has also been freezes for 4% for another two years.
- 2. Society Balance sheet for year 2017-18 has been signed by the members after detailed discussion.
- Income Tax department notice for assessment year 2016-17 has been received on 24<sup>th</sup> Aug 2018. Whereas, assessment proceedings supposed to be conducted manually by the
